

**City of Cody
Council Proceedings
Tuesday, December 3, 2013**

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, December 3, 2013 at 7:00 p.m.

Present: Mayor Nancy Tia Brown, Council Members Donny Anderson, Bryan Edwards, Landon Greer, Steve Miller and Stan Wolz, City Administrator Jenni Rosencranse, City Attorney Scott Kolpitzke and Administrative Services Officer, Cindy Baker.

Mayor Brown called the meeting to order at 7:00 p.m.

Council Member Miller made a motion seconded by Council Member Fritz to approve the agenda as presented. Vote was unanimous.

Council Member Miller made a motion seconded by Council Member Fritz to approve the consent calendar including approval of Minutes of the Special Meeting from 11/14/13 and Regular Meeting from 11/19/13; approve Vouchers and Payroll in the amount of \$611,944.79; authorize the Mayor to enter into and sign an agreement between the City of Cody and Experience Works for the purpose of a joint engagement in the Senior Community Service Employment Program (SCSEP); approve entering into a Project Development and Administration Agreement between the City of Cody, Forward Cody and the Schmidt Lee Institute of Surgical Anatomy, LLC and authorize the Mayor to sign agreement contingent upon review and approval by the City Attorney. Vote was unanimous.

Council Member Anderson made a motion seconded by Council Member Wolz to approve the revised Revenue Recapture Plan for the Wyoming Business Council Schmidt Lee Grant Project and authorize the Mayor to sign the revised document. Vote was unanimous.
