

**City of Cody
Council Proceedings
Tuesday, January 21, 2014**

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, January 21, 2014 at 7:00 p.m.

Present: Mayor Brown , Council Members Donny Anderson, Bryan Edwards, Steve Miller and Stan Wolz, City Administrator Jenni Rosencranse, City Attorney Scott Kolpitcke and Administrative Services Officer, Cindy Baker.

Absent: Council Member Landon Greer.

Council Mayor Brown called the meeting to order at 7:00 p.m.

Council Member Miller made a motion seconded by Council Member Fritz to approve the agenda as amended to add item “e”, “f” and “g” to the consent calendar. Vote was unanimous.

Mayor Brown and the Council presented appreciation plaques to Bud McDonald and Rick Brasher for their service on the Planning, Zoning and Adjustment Board; Bill Holder for his services on the Yellowstone Regional Airport Board and Morgan Lee for her service on the Contractor’s Board.

Council Member Miller made a motion seconded by Council Member Fritz to approve the consent calendar as amended including approval of the Special Meeting Minutes from 1/2/14, and Regular Meeting Minutes from 1/7/14; approval of vouchers and payroll in the amount of \$1,474,677.88; authorize the Mayor to sign the SSBCI quarterly Certification on Use-of-Allocated Fund; authorize the Mayor to sign the bylaws as approved and presented by the Laramie SSBCI Consortium; appoint Marty Coe, Aaron Danforth, L.J. O’Mara and Diane Russell to the Cody Tree Board for a 2 year tem ending December 31, 2015; appoint Kathy Croft and Kathy McDonald to the Urban Systems Board for a three year term ending December 31, 2016; appoint Ted Lee and Isaac Reyesmejia to the Veterans Memorial Park Committee for a 1 year term ending December 31, 2014. Vote was unanimous.

ZONING DISTRICT.** Council Member Wolz made a motion seconded by Council Member Anderson to approve Ordinance 2013-19 on third and final reading as amended. Vote was unanimous.

ZONING DISTRICT.** Council Member Fritz made a motion seconded by Council Member Wolz to approve Ordinance 2013-21 on third and final reading. Vote was unanimous.
