

**City of Cody**  
**Council Proceedings**  
**Tuesday, November 19, 2019**

A regular meeting of the Cody City Council was held in the Council Chambers at City Hall in Cody, Wyoming on Tuesday, November 19, 2019 at 7:00 p.m.

Present: Mayor Matt Hall, Council Members, Jerry Fritz, Landon Greer, Diane Ballard, Justin Baily, Glenn Nielson and Heidi Rasmussen, City Administrator Barry Cook, City Attorney Scott Kolpitcke, and Administrative Services Officer, Cindy Baker.

Absent: None

Mayor Hall called the meeting to order at 7:00 p.m.

**Proclamation – Small Business Saturday**

Council Member Greer made a motion seconded by Council Member Rasmussen to approve the Consent Calendar as presented. Consent calendar approved included the approval of Minutes: Regular Minutes from November 5, 2019, And Special Work Session Minutes from November 12, 2019; authorize the sale of a Hi-Lite Body Armor ballistic Police Vest to the Town of Jackson in the amount of \$350; and authorize the Mayor to sign a ballot voting for Chris Meats and Richard C. Grant, Jr. to be elected to the Local Government Liability Pool board for terms beginning January 1, 2020. Vote was unanimous.

Council Member Fritz made a motion seconded by Council Member Ballard to approve Vouchers and payroll in the amount of \$2,224,588.46. Council Member Greer recused himself from the vote. Vote was unanimous from remaining Council Members.

Council Member Fritz made a motion seconded by Council Member Rasmussen to approve a request from the Cody Racquetball Club to allow alcohol at the Rec Center after hours during the Cody Racquetballs Classic Tournament to be held on December 6, 7 and 8, 2019. Mayor Hall recused himself from the discussion and vote. Vote in favor were Council Members Rasmussen, Fritz, Baily and Ballard. Voting opposed were Council Members Green and Nielson. Motion passed.

There being no further action Council President adjourned the meeting at 7:14 p.m.
