City of Cody Board Information

In general, applicants should be a resident of the City of Cody. All City of Cody Boards are established in the interest and benefit of City of Cody residents. Applicants must be able to commit both time and energy to the boards in which they serve in an effort to make fair, consistent and informed recommendations and decisions for Cody's Governing Body.

The following is a brief description of each board. For more detailed information please contact the person listed under each board.

Airport Board – three year term

The Yellowstone Regional Airport Board (YRAB) is comprised of 4 members appointed by the City of Cody and 3 members appointed by Park County. There is also one Council member who serves as a liaison on the board, but does not vote. In addition, Yellowstone Regional Airport receives 60% of its operational funding from the City of Cody and 40% from Park County. The YRAB meets on the 2nd Wednesday of each month at 8:00 a.m. The Board directly oversees the Airport Executive Director, all budget aspects of the Airport and in general plans for the future by providing a means to operate and safely maintain an aviation facility adequate for the needs of the public. Planning, Zoning and Adjustment Board – three year term

The Planning, Zoning and Adjustment Board (P & Z) is made up of seven voting members and one Council liaison member. The P & Z Board meets on the 2nd and 4th Tuesdays of each month at noon in Cody City Council Chambers. The meetings are televised on Channel 16 for the public to view. The P & Z Board listens and makes recommendations to the Governing Body on Planning and Zoning issues such as variances, zone changes, special exemptions, vacations, signs, subdivision development and a variety of other issues. Cody Tree Board – two year term

The Cody Tree Board is comprised of up to 9 members who are residents or conduct business in Cody and are appointed by the Governing Body. The Cody Tree Board meets as needed. It shall be the responsibility of the city tree board to study, investigate, counsel, and develop written standards, rules and regulations for the care, preservation, pruning, planting, replanting, removal or disposition of trees and shrubs in public ways, streets and alleys. Such standards will be presented to the Governing Body and, upon their acceptance and approval, shall constitute the official city "tree rules and regulations". The City Tree Board, when requested by the Governing Body, shall consider, investigate, make findings, report and recommend upon any special matter or question coming within the scope of its responsibilities. In addition they coordinate National and local events and projects including the Arbor Day Event. For more information, please contact Monte Bales at 307-527-5275.

Contractor's Board – three year term

The Contractor's Board is made up of nine voting members and is appointed by the Governing Body. The Contractor's Board shall be made up of the following: 1 at large resident of the City, 1 architect or civil engineer, 1 Council member, 2 licensed building contractors with at least 5 years of experience, 2 licensed plumbing contractors with at least 5 years of experience and 2 licensed electrical contractors with at least 5 years of experience. The Contractor's Board meets on the 4th Thursday of each month at noon at the Holiday Inn. The purpose of the board is to review and approve contractors for licensure, to serve as an appeals board for the licensed contractors, and to recommend policy and procedure as it relates to building and code compliance. Urban Systems – 3 year term

The purpose of the Urban Systems Board is to provide planning, organization, and construction assistance for urban transportation improvements intended to benefit the traveling public, accommodate increasing street and highway system traffic capacity, and improve overall safety.

The Veterans Memorial Park Committee is comprised of 11 members. The Committee consists of veterans, at-large members, Councilmembers, City staff members, and WY State Parks representatives.
